Competitive Program Report

- The Competitive Team athletes finished up their "regular season" on March 3-5 with the Level 3-5 athletes in Minot at the Rebel Roundup and the Level 6-9 athletes in Minneapolis at the Northern Lights Classic. At the Rebel Roundup, the Level 3s finished 2nd as a team and the Level 5s were Team Champs. At Northern Lights, we had several finishers in the top 5. Our Competitive athletes will compete at the NDUSAG State Championships in Minot on March 17-19. The Region 4 Championships will be held in Milwaukee, WI on April 13-17 for Level 6-9 qualifiers. Western Championships will be held in Boise, ID on May 4-7 for Level 9 qualifiers.
- Pre-Comp Team Tryouts will be held at BGA on Saturday, March 25. Xcel Team Tryouts are tentatively planned for Saturday, April 22. We are currently working to hire coaching staff for the Xcel Program with the goal of starting Xcel Team practices in the summer.
- Our competitive floor carpet from the 2022 BPRD Match Grant is currently en route to BGA. We have several
 mats that have been ordered that are ready for shipment. We are hoping to bundle shipping with the mats
 approved in the 2023 BPRD Match Grant.

Grants:
