# **February Board Report 2023**

<u>Office:</u> We have been actively seeking appropriate candidates to fill the Operations Manager position. Interviews and job shadows have begun. We are hopeful it will be filled very soon.

We have worked alongside Padgett and Schmitz Holmstrom to complete taxes this year, file annual reports, and update all insurance policies.

# **Fundraising/ Business and Community:**

<u>Pro-Shop:</u> The pro-shop remains open for in person vending of leos, drinks, snacks, and BGA car/ water bottle stickers. The year round online pro-shop is live and available to membership. This has been promoted through Facebook, Instagram, twitter, our website, and email. We have added "Rip Guards" (a temporary glove designed to help gymnasts to prevent or heal from rips on the bar), scrunchies, and doll leotards to our in person pro shop.

<u>Grants:</u> We are continuing to follow up with BPRD on the delivery of our new competitive carpet. We have utilized the CVB event grant to offset costs for our Ziegler meet. BGA Was approved for the 1<sup>st</sup> round of the BPRD Matching grant program. This year's match is replacement mats for our competitive uneven bars and balance beams. BGA's contribution is \$3,500. We will collaborate with BPRD to order the mats.

<u>Charitable Gaming:</u> BGA is continuing with our charitable gaming efforts with both Buffalo Wild Wings South and LUFT Rooftop Bar. We continue to seek out relationships with other establishments to increase our site opportunities. Jo testified in the Senate Judiciary Committee in opposition to a bill that would've impacted our relationship with restaurants with a bar inside.

<u>Cheesecake/ dessert roll Fundraiser:</u> We were partnered with Inspire Fundraising for our Winter Fundraiser. Packets were distributed the week of December 12<sup>th</sup> and were due back to the office Thursday, January 5<sup>th</sup>, 2023. With the blizzard and necessary closures of the gym, we had diminished participation. The product was distributed on Wednesday February 8<sup>th</sup>.

<u>Butter Braid Fundraiser:</u> BGA is partnering with Fresh Alternative Fundraising for our Spring Session fundraiser. Packets will be distributed during the week of March 13<sup>th</sup> with a turn in date of Thursday March 30<sup>th</sup>.

<u>Ziegler meet:</u> Final numbers are being calculated as we still have some expenses to be reconciled. Padgett is preparing a report that will be sent out as soon as possible. This will then be presented at the March Board meeting.

<u>Safety Champion</u>: Jo continues to stay educated though USAG communication regarding the Safety Champion role. <u>Community Outreach</u>: we have an opportunity to represent the nonprofit portion of a new chapter of a BNI group. This is a networking and referral group and should be a great opportunity for BGA. The first year for the nonprofit seat is free of charge.

The next Bismarck Mandan Chamber EDC "Local Issues" Committee Meeting will be held on March 7th at the Chamber main office. Jo will be in attendance.

BGA continues to attend monthly Bismarck Mandan Chamber EDC mixers.

Jo continues to work with "Do Good Youniversity" following the "Do Good Better" conference to foster and maintain fundraising contacts and best practice methods moving forward.

### **Competitive Program Report**

The Competitive Team athletes finished up the month of January by competing at the Starstruck Qualifier in Mandan on January 21-22 and the TNT Winter Challenge in Fargo on January 28-29. Our Optional-level gymnasts competed at the Winter Spectacular in St. Paul, MN on February 3-5 while our Compulsory-level gymnasts competed at the Blast in the Badlands in Watford City on February 10-12. We had 4 of our Optional-level gymnasts compete at the WOGA Classic in Frisco, TX on February 17-19 while the remainder of our Compulsory- and Optional-level gymnasts competed at the Winter Escape in Jamestown that same weekend. There have been ups and downs throughout competitions, but the girls have worked hard in practice and have continued to meet goals. We will finish off the "regular season" with the Compulsories at the Rebel Round-Up in Minot and the Optionals at Northern Lights in Minneapolis on March 3-5 followed by NDUSAG State Championships in Minot on March 17-19.

Our new equipment purchases have continued to trickle in throughout the past year. We have now received all of the equipment ordered with the exception of a few mats which are ready to ship.
